ITEM DESCRIPTION

- 1 SCOPE:
 - 1.1 The purpose of this procurement is to Layout, Procure, Deliver, and Install Furniture. Provide all required labor, tools, materials, and equipment to accomplish this requirements.
 - 1.2 Location of work: At building 1481 2nd Floor COMPACFLT N4 Port Visit Manager (PVM) Office in U.S. Naval Base Sasebo Japan
 - 1.3 See DELIVERY INFORMATION on SF 1449. Coordinate delivery schedule with the Government Technical POC. Deliver and install all items to the designated delivery location by *[40 days After Date of Contract (ADC). This is preferred completion date and actual completion date will be specified upon award]*. Complete other related works by the expiring date of this contract.
 - 1.3.1 Regular working hours shall consist of an 8-hour period, between 07:30 and 16:30, Monday through Friday, excluding U.S. Government holiday.
 - 1.3.2 Specific work schedule and sequence of work shall be coordinated closely with the Government Technical POC to minimize interruption of a work and accomplish all requirements on this SOW and other related works during this period.

- 3 REQUIREMENTS:
 - 3.1 General, Safety, and Security Requirements.
 - 3.1.1 Assign a Contractor Project Manager (CPM). The CPM has responsibility for management and shall notify the Government Technical POC and the Contracting POC of any changes or issues through completion of this requirement. The CPM must respond and meet within 36 hours of a meeting request.
 - 3.1.2 Comply with all the Sasebo Naval Base rules and regulations applicable to safety, security, and procedures governing site entry and exit.

 - 3.2 Create technical exhibits (floor plan and catalog cut).
 - 3.2.1 The furniture that the contractor intends to install must meet and fit the requirements of each location stated in paragraph 3.3 below. SOW Attachment 01, Floor Plan is layout sketch for reference purpose only.
 - 3.2.2 All size stated in this SOW and any contractor's technical exhibits are unified by millimeter (mm).
 - 3.2.3 Isle space shall be at least minimum 710.
 - 3.2.5 Measure and consider any conditions of each location to create technical exhibits. Stated room size at para 3.3 are informational purpose only.
 - 3.2.6 The Government will consider any items proposed that contain minor size variations or other variations based on the item's ability to fit in the specific location.
 - 3.2.7. All furniture shall be of cohesive design and color scheme. Wood-grain table and dark color chair are ideal: specific color and fabric selections to be made after award without the cost change.

 - 3.3 Provide, fabricate, and install following furniture in accordance with the accepted technical exhibit at paragraph 3.2. Inside dimension of PVM Office is approximately 9724 x 6348.
 - 3.3.1 Back Area for 4 Cubicle partitioned work areas (minimum 2600 x 2250 per cubicle)

- a. 4 Work Surface, L-Shape with height adjustment ability (power outlets available). Ability to hide computer cables and other wires. (Minimum W1800 x D1800 x H720)
- b. 4 Light, Adjustable Task style, LED
- c. 4 Movable Drawer (3 Drawers, Key lock, minimum W400 x D590 x H510) able to fit under lowered work surface.
- d. 4 Movable Drawer (2 Drawers, Key Lock, minimum W400 x D590 x H510)) able to fit under lowered work surface.
- e. 4 Office Chair; wheeled, basic ergonomics, with arm rest, head rest, and mesh material. No foot rest.
- f. 4 Clothing locker (minimum W450 x D515 x H1790) able to fit between work surface and privacy wall.
- g. Privacy Walls for each desks (Gray color is preferable). Frame is black or dark color. Privacy Wall height should be minimum 1735.

- a. 1 Conference Table (power outlets available at table) (W2400 x D1200 x H720 or larger)
- b. 4 Swivel Chair (compatible in size with conference table), wheeled, basic ergonomics, with arm rest and mesh material. No head rest or foot rest.
- c. 2 Cabinet w/ double door (minimum W900 x D450 x H1038), adjustable shelves and counter top (able to provide enough clearance below installed ADP server cabinet)

3.4 After completion of the installation, remove all trash and clean each room.

- 3.4.1 Dispose of all debris and rubbish resulting from the requirement under this contract off U.S. Government property and at approved facilities for such disposal in accordance with Japanese law and local regulations at contractor's expense.
 - 3.4.1.1 Dispose of any and industrial waste in accordance with Department of Defense (DOD) Japan Environmental Governing Standards (JEGS), Japanese Laws, Nagasaki-ken Kohgai Bohshi Jyorei Kitei Shu (handbook for Pollution Control Laws and Official Regulations), and Occupational Safety and Health Administration (OSHA), U.S. Army Corps of Engineering (USACE) Engineering Pamphlet. Submit proof of proper disposition (an authenticated disposal ticket or a copy of manifest) to the Government Technical POC prior to Government acceptance of the work.
 - 3.4.1.2 Unless otherwise specified or directed, do not dispose any hazardous wastes in to any area outside the Government control area. Inform of any hazardous wastes to the Government Technical POC for the notification purpose to the Base/Station Environmental Hazardous Waste Disposal Branch, Environmental Division, in writing and coordinate setting up the boxes with the Government Technical POC. Submit Hazardous Waste Disposal Disposition form provided by the Government Technical POC.
- 3.4.2 Damage caused by the contractor such as scratch, scraped paint, dent, bent structures shall be restored to its original condition by the contractor.

CLAUSES INCORPORATED BY FULL TEXT

52.204-21 BASIC SAFEGUARDING OF COVERED CONTRACTOR INFORMATION SYSTEMS (NOV 2021)

(a) Definitions. As used in this clause--

Covered contractor information system means an information system that is owned or operated by a contractor that processes, stores, or transmits Federal contract information.

Federal contract information means information, not intended for public release, that is provided by or generated for the Government under a contract to develop or deliver a product or service to the Government, but not including information provided by the Government to the public (such as on public websites) or simple transactional information, such as necessary to process payments.

Information means any communication or representation of knowledge such as facts, data, or opinions, in any medium or form, including textual, numerical, graphic, cartographic, narrative, or audiovisual (Committee on National Security Systems Instruction (CNSSI) 4009).

Information system means a discrete set of information resources organized for the collection, processing, maintenance, use, sharing, dissemination, or disposition of information (44 U.S.C. 3502).

Safeguarding means measures or controls that are prescribed to protect information systems.

(b) Safeguarding requirements and procedures.

(1) The Contractor shall apply the following basic safeguarding requirements and procedures to protect covered contractor information systems. Requirements and procedures for basic safeguarding of covered contractor information systems shall include, at a minimum, the following security controls:

(i) Limit information system access to authorized users, processes acting on behalf of authorized users, or devices (including other information systems).

(ii) Limit information system access to the types of transactions and functions that authorized users are permitted to execute.

- (iii) Verify and control/limit connections to and use of external information systems.
 - (iv) Control information posted or processed on publicly accessible information systems.
 - (v) Identify information system users, processes acting on behalf of users, or devices.
 - (vi) Authenticate (or verify) the identities of those users, processes, or devices, as a prerequisite to allowing access to organizational information systems.
 - (vii) Sanitize or destroy information system media containing Federal Contract Information before disposal or release for reuse.
 - (viii) Limit physical access to organizational information systems, equipment, and the respective operating environments to authorized individuals.
 - (ix) Escort visitors and monitor visitor activity; maintain audit logs of physical access; and control and manage physical access devices.
 - (x) Monitor, control, and protect organizational communications (i.e., information transmitted or received by organizational information systems) at the external boundaries and key internal boundaries of the information systems.
 - (xi) Implement subnetworks for publicly accessible system components that are physically or logically separated from internal networks.
 - (xii) Identify, report, and correct information and information system flaws in a timely manner.
 - (xiii) Provide protection from malicious code at appropriate locations within organizational information systems.
 - (xiv) Update malicious code protection mechanisms when new releases are available.
 - (xv) Perform periodic scans of the information system and real-time scans of files from external sources as files are downloaded, opened, or executed.
- (2) Other requirements. This clause does not relieve the Contractor of any other specific safeguarding requirements specified by Federal agencies and departments relating to covered contractor information systems generally or other Federal safeguarding requirements for controlled unclassified information (CUI) as established by Executive Order 13556.
- (c) Subcontracts. The Contractor shall include the substance of this clause, including this paragraph (c), in subcontracts under this contract (including subcontracts for the acquisition of commercial products or commercial services, other than commercially available off-the-shelf items), in which the subcontractor may have Federal contract information residing in or transiting through its information system.

(End of clause)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Prohibition.

(1) Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(2) Section 889(a)(1)(B) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(2) In the event the Government is unable to release one or more payments by EFT, the Contractor agrees to either--

- (i) Accept payment by check or some other mutually agreeable method of payment; or
- (ii) Request the Government to extend payment due dates until such time as the Government makes payment by EFT (but see paragraph (d) of this clause).

(b) Mandatory submission of Contractor's EFT information. (1) The Contractor is required to provide the Government with the information required to make payment by EFT (see paragraph (j) of this clause). The Contractor shall provide this information directly to the office designated in this contract to receive that information (hereafter: “designated office”) by **the date when the contractor submit first invoice, using EFT Form established by DFAS.** If not otherwise specified in this contract, the payment office is the designated office for receipt of the Contractor's EFT information. If more than one designated office is named for the contract, the Contractor shall provide a separate notice to each office. In the event that the EFT information changes, the Contractor shall be responsible for providing the updated information to the designated office(s).

(2) If the Contractor provides EFT information applicable to multiple contracts, the Contractor shall specifically state the applicability of this EFT information in terms acceptable to the designated office. However, EFT information supplied to a designated office shall be applicable only to contracts that identify that designated office as the office to receive EFT information for that contract.

(c) Mechanisms for EFT payment. The Government may make payment by EFT through either the Automated Clearing House (ACH) network, subject to the rules of the National Automated Clearing House Association, or the Fedwire Transfer System. (e) Liability for uncompleted or erroneous transfers. (1) If an uncompleted or erroneous transfer occurs because the Government used the Contractor's EFT information incorrectly, the Government remains responsible for--

- (i) Making a correct payment;
- (ii) Paying any prompt payment penalty due; and
- (iii) Recovering any erroneously directed funds.

(2) If an uncompleted or erroneous transfer occurs because the Contractor's EFT information was incorrect, or was revised within 30 days of Government release of the EFT payment transaction instruction to the Federal Reserve System, and--

However, the Government does not guarantee that any particular format or method of delivery is available at any particular payment office and retains the latitude to use the format and delivery method most convenient to the Government. For items that are serialized within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier and a unique serial number. For items that are serialized within the part, lot, or batch number within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

(ii) The encoded data elements of the unique item identifier conform to the transfer structure, syntax, and coding of messages and data formats specified for Format Indicators 05, 06, and 12 in ISO/IEC International Standard 15434, Information Technology-Transfer Syntax for High Capacity Automatic Data Capture Media.

L. 116-92), DoD is prohibited from entering into a contract for the procurement of products or services with any person that has business operations with an authority of the government of Venezuela that is not recognized as the legitimate government of Venezuela by the U.S. Government, unless the person has a valid license to operate in Venezuela issued by the Office of Foreign Assets Control of the Department of the Treasury.

(c) The Contractor shall--
