STATEMENT OF WORK

## 1. SCOPE:

- 1.1 The purpose of this procurement is to provide steel one 6 ft. Platform and three 40 ft. Brows at Commander Fleet Activities Sasebo (CFAS). The Contractor shall furnish labor, materials, equipment, transportation and supervision necessary to perform this project. The Contractor shall provide and secure this construction, complete and ready for use. The Contractor shall perform work required under this contract, as indicated in this document specification and attached drawings.

- 1.3 Coordinate delivery schedule with the Government Technical Point of Contact (Govt TPOC). Other related works shall be completed by the expiring date of this order. If the contractor realizes any potential or actual delay in delivery, report to the Government Contracting POC via the Government Technical POC.

## 3. REQUIREMENTS:

3.1 Specification

The contractor shall design and fabricate Platform and Brow to meet the following requirements in reference to the attachment (1), (2) and (3). All required structural size and materials on

attachment. Indicate actual weight and name for each on noticeable portions of 6 feet high platform and 40 feet brow.

**3.1.1 Design Criteria of Platform:** Design the platform to meet the following requirements:

- a. Size: The required platform is basically, tower and stairs, with typical measurement of 15.5' x 7.5' at the base and 6' in height, which is to be used at berth. The new brow (40' length) is used for personnel movement from the ships to the top of the platform. The platform contains removable stairs from its top to the wharf deck. Platform is used when a brow from ship deck to wharf deck is not practical.
- b. Width of the stairs: Width shall be 36 inch (0.91 m) minimum (clear) passage for one-way traffic. All treads shall be reasonably slip-resistant.
- c. Handrails: Installed on stair. Design handrails to resist 50 lbs per lineal foot (74.3 kg per lineal meter) applied in any direction at the top. Design handrails to resist a single concentrated load of 200 lbs (90.6 kg) applied at any direction at any point along the top. It is assumed that the uniform load and the concentrated load do not act concurrently.
- d. Live Load: The platform structure shall be designed for a uniform live load of 75 lbs/ft<sup>2</sup> (366 kg/m<sup>2</sup>) and a concentrated live load of 200 lbs (90.6 kg) applied anywhere as same as the live load of platform. Also, the platform shall be structurally strong enough to connect with the brow.
- e. Stanchion: Design stanchions to provide 1 inch (D) and 3 feet 6 inch height steel pipe (13) with ring (2) for chain and due to easy to removable, attach 6 inch poles to the top of the deck to secure the stanchion. Also, two proper length of 1/4 inch chain are attached between the poles.
- f. Construction Material: Steel structure shall be used with corrosion control. Chain and shackles shall be used CRES.
- g. Safety Requirement: Handrails, stanchion and access plate shall have enough capability to hold for fall protection.
- h. Anchoring of the brow platform will be provided by other
- i. Positions of platform and brow are moving by shifting tide level. Reinforcement material shall be provided on the top corner edge facing to the ship side so as not to damage platform and brow.
- j. On the top floor surface of the platform, guide rails for brow shall be provided. Width of the guide rail shall be widened as much as possible.
- k. Construction details is referred attached drawing on Attachment (1)

**3.1.2 Design Criteria of Brow:** Design of the brow to meet the following requirements:

- a. Length: Brow shall be of 40 feet (12.2 m) length
- b. Width: Width shall be 36-in. (0.91 m) minimum (clear) passage.
- c. Construction Material: Steel structure shall be used with corrosion control.
- d. Rubber Tire: Shall be provided for operation efficiency.

e. Live Load: The brow structure shall be designed for a uniform live load of 75 lbs / ft<sup>2</sup> (366 kg/m<sup>2</sup>) and a concentrated live load 200 lbs. (90.7 kg) applied noticeable portion.

f. Handrails: Design handrails to resist 50 lbs. per lineal foot (75.6 kg per lineal meter) applied in any direction at the top. Design handrails to resist a single concentrated load of 200 lbs. (90.7 kg) applied at any direction at any point along the top. It is assumed that the uniform load and the concentrated load do not act concurrently. The handrail may be designed to serve as the top chord of a when sufficiently braced.

g. Lifting Eye: Hook plates shall be provided at the four top corners of the brow so that the brow can be hoisted up for relocation. Lifting eyes shall be structurally capable of hoisting up with two lifting eyes. Generally, lifting pad eye shall be used at four (4) points to lift the brow. However, brow weight will be loaded to two (2) points during installation on board. Contractor shall design and install lifting pad eye considering each lifting pattern using two (2) points and four (4) points. Contractor shall install "LIFTING POINT" plate on each lifting pad eye. The "LIFTING POINT" label shall be engraved or printed.

h. Safety Requirement: Provide safety device to keep the brow from rolling off the platform deck and to prevent movement of the platform while in use. Clip safety chains into position for personnel safety.

i. Tie Down Point

Four tie down rings or eye plates each shall be installed to the brow as a tie down point which is used for the purpose of connection to tie the brow with ship structure or dock pier cleat to prevent slipping and/or falling of the brow. Strength of each tie down ring or eye plate shall be more than brow weight which can support the brow itself. Eye opening shall be minimum 1 1/8". Contractor shall install "TIE DOWN POINT" plate on each Tie down point. The "TIE DOWN POINT" label shall be engraved or printed.

j. Toe Board

Toe board shall be installed on both sides toward walkway. Height of the toe board shall be minimum 4" from walkway floor level.

k. Ship side connection

Ship connection by cannal stopper shall be installed end and under of brow which is against side of rubber tire.

l. Construction details is referred attached drawing on Attachment (2) and (3)

3.1.3 **Certificates:** Verify all certificates and licenses required to perform the contractual work. The items listed below are the part of Certificates required. When required by GOVT, copy of certificate shall be provided.

a. Licenses by the prefectural governor or a local government entity for Industrial Waste transportation, treatment and/or disposal.

b. Certificates of Compliance: A certificate from the manufacturer stating that the product conforms to requirements of the referenced specification, such as certifications of lead and/or asbestos quantities contained in each materials. Also, additional one set of copy is required to submit.

c. Certificates of welding workers: A certificate providing that welding workers are qualified by performance test in accordance with JIS Z 3801 titled "Standard qualification procedure

for manual welding technique” or JIS Z 3841 titled “Standard qualification procedure for semi-automatic welding technique”

d. Certification of Non-destructive Testing: A qualification and certificate proving that penetrant testing workers are qualified by performance test in accordance with JIS Z 2305 titled” Non-destructive testing -- Qualification and certification of NDT personnel.”

#### 3.1.4 **Materials**

Materials: All materials shall be furnished by the Contractor and shall confirm to the respective requirements stipulated below. Unless otherwise specified in this document, materials to be used under this contract shall be the materials conforming to the applicable requirements of JIS and Standards specified in reference (C). In case material conforming to JIS is not available, submit data and applicable standards/regulations of the material for the Contracting Officer's approval. All materials shall be new except where indicated as existing or reused.

Materials for Civil Work: No special requirement other than specified in each drawing is contained.

#### 3.1.5 **Preservation and Painting**

Contractor shall apply three coats paint on the brow. All paint shall be lead free type.

- (1) Surfaces of floor, steps, stair landings: Non-slip paint
- (2) Other portions: 5-coats of epoxy paint
- (3) Final coat shall be gray.
- (4) Lifting pad eye shall be painted yellow.
- (5) Tie down point shall be painted white.
- (6) Walkway floor of platform shall be non-slip coating of gray.

### 3.2 **Inspection and Operational Test**

Contractor shall perform inspection and operational test for all brows to meet the following requirements prior to delivery. The Government will have the option to attend and witness test.

#### 3.2.1. **Visual inspection**

Contractor shall inspect the platform and brow in accordance with reference(c) and manufacturer's production procedure or welding standard.

#### 3.2.2 **Dimension inspection**

Contractor shall measure the brow dimension based on drawing in accordance with manufacturer's production procedure.

#### 3.2.3. **Welding inspection**

Contractor shall perform NDT (Non-Destructive Test) for the following item.

- (1) All lifting pad eye
- (2) Ship connection
- (3) Main member partially

#### 3.2.4. **Operation test for Brow**

Contractor shall perform operational test in accordance with following procedure. If contactor fabricate a splice brow, the contractor shall confirm lifting condition after assembly.

##### 3.2.4.1 Lifting by four (4) pad eye

Contractor shall lift the brow by four (4) pad eye with no load.

3.2.4.2 Lift by two (2) pad eye lifting

Contractor shall lift the brow by each pair of all padeye with no load. Lifting side of brow shall be suspended without floating another side. The testing shall be repeated for opposite side by lifting another pair of lifting padeye.

3.2.4.3 Measurement of actual weight

Contractor shall measure actual brow weight after the fabrication is completed.

3.2.5 Load Test

Contractor shall perform load test for platform and all brows. This load test is confirmed for each live load. Test load shall be ideal 100 PSF for the purpose of calculation. Contractor shall inspect platform and brows which has no damage, no crack and no deformation after load test.

3.3 Lifting Plan

Lifting plan for the brow that is required for transportation and operation shall be provided with drawing and calculation.

3.4 Delivery

3.4.1 The contractor shall deliver the platform and brow to CFAS after the inspection operation test are completed.

3.4.2 The contractor shall provide mobile crane, required rigging gears and labor for unloading and assembly of the brow at laydown area where will be designated by the Government. The Government will not provide any crane service nor lifting equipment.

3.5. Document submission

3.5.1 **Pre-Fabrication Approval documents**

The contractor shall submit the following documents to the Govt TPOC for review and approval before the start of work, no later than twenty-five (25) working days after contract award. Government technical review will be completed and returned with comments within ten (10) working days after receipt from the contractor.

- (a) Drawing
- (b) Capacity
- (c) Lifting plan
- (d) Accessories list
- (e) Work schedule
- (f) Manufacture's Production Procedure and Welding Standard

3.5.2 **Operation Test and Load Test Documents**

The contractor shall submit the Operational test and load test item and procedure to Govt TPOC for review and approval before twenty-five (25) working days of the operational test. The Government technical review will be completed and returned with comments within ten (10) working days after receipt from the contractor.

3.5.3 **Completion Documents**

The contractor shall submit the following three (3) hard copy sets and one (1) PDF/CAD data set of completion documents when the brow and platform are delivered.

- (1) As-Built Drawing (Principal dimensions written by imperial and metric.)
- (2) Fabrication information (picture, sketch, etc.)
- (3) Lifting Plan (include photo, sketch, calculation, etc.)
- (4) Load test result (include photo, calculation)
- (5) Operational test result (photo, etc.)

- (6) Brow and platform certification by manufacture or organization
- (7) Material certification
- (8) Material list
- (9) Visual inspection and dimensional check result
- (10) Spare parts catalog

3.6 General Safety, Environmental and Equipment Requirements

3.6.1 The equipment specified herein shall comply with the applicable OSHA regulations.

3.6.2 The equipment shall be designed and constructed so that during the operation, service, transportation, and storage conditions described herein including final disposal, the equipment will comply with Environmental Protection Agency (EPA) and Occupational Safety and Health Agency (OSHA) and local environmental agency restrictions for materials classified as hazardous to the environment in effect on the date of the contract.

#### CLAUSES INCORPORATED BY FULL TEXT

52.204-21 BASIC SAFEGUARDING OF COVERED CONTRACTOR INFORMATION SYSTEMS (NOV 2021)

(a) Definitions. As used in this clause--

Covered contractor information system means an information system that is owned or operated by a contractor that processes, stores, or transmits Federal contract information.

Federal contract information means information, not intended for public release, that is provided by or generated for the Government under a contract to develop or deliver a product or service to the Government, but not including information provided by the Government to the public (such as on public websites) or simple transactional information, such as necessary to process payments.

Information means any communication or representation of knowledge such as facts, data, or opinions, in any medium or form, including textual, numerical, graphic, cartographic, narrative, or audiovisual (Committee on National Security Systems Instruction (CNSSI) 4009).

Information system means a discrete set of information resources organized for the collection, processing, maintenance, use, sharing, dissemination, or disposition of information (44 U.S.C. 3502).

Safeguarding means measures or controls that are prescribed to protect information systems.

(b) Safeguarding requirements and procedures.

(1) The Contractor shall apply the following basic safeguarding requirements and procedures to protect covered contractor information systems. Requirements and procedures for basic safeguarding of covered contractor information systems shall include, at a minimum, the following security controls:

(i) Limit information system access to authorized users, processes acting on behalf of authorized users, or devices (including other information systems).

(ii) Limit information system access to the types of transactions and functions that authorized users are permitted to execute.

(iii) Verify and control/limit connections to and use of external information systems.

(iv) Control information posted or processed on publicly accessible information systems.

(v) Identify information system users, processes acting on behalf of users, or devices.

(vi) Authenticate (or verify) the identities of those users, processes, or devices, as a prerequisite to allowing access to organizational information systems.

(vii) Sanitize or destroy information system media containing Federal Contract Information before disposal or release for reuse.

(viii) Limit physical access to organizational information systems, equipment, and the respective operating environments to authorized individuals.

(ix) Escort visitors and monitor visitor activity; maintain audit logs of physical access; and control and manage physical access devices.

(x) Monitor, control, and protect organizational communications (i.e., information transmitted or received by organizational information systems) at the external boundaries and key internal boundaries of the information systems.

(xi) Implement subnetworks for publicly accessible system components that are physically or logically separated from internal networks.

(xii) Identify, report, and correct information and information system flaws in a timely manner.

(xiii) Provide protection from malicious code at appropriate locations within organizational information systems.

(xiv) Update malicious code protection mechanisms when new releases are available.

(xv) Perform periodic scans of the information system and real-time scans of files from external sources as files are downloaded, opened, or executed.

(2) Other requirements. This clause does not relieve the Contractor of any other specific safeguarding requirements specified by Federal agencies and departments relating to covered contractor information systems generally or other Federal safeguarding requirements for controlled unclassified information (CUI) as established by Executive Order 13556.

(c) Subcontracts. The Contractor shall include the substance of this clause, including this paragraph (c), in subcontracts under this contract (including subcontracts for the acquisition of commercial products or commercial services, other than commercially available off-the-shelf items), in which the subcontractor may have Federal contract information residing in or transiting through its information system.

(End of clause)

#### 52.204-24 REPRESENTATION REGARDING CERTAIN TELECOMMUNICATIONS AND VIDEO SURVEILLANCE SERVICES OR EQUIPMENT (NOV 2021)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it "does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument" in paragraph (c)(1) in the provision at 52.204-26, Covered Telecommunications Equipment or Services-- Representation, or in paragraph (v)(2)(i) of the provision at 52.212-3, Offeror Representations and Certifications-- Commercial Products and Commercial Services. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it "does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services" in paragraph (c)(2) of the provision at 52.204-26, or in paragraph (v)(2)(ii) of the provision at 52.212-3.

(a) Definitions. As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Prohibition.

(1) Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(2) Section 889(a)(1)(B) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (Pub. L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to--

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(ii) For covered services--

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the Product Service Code (PSC) of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(2) Disclosure for the representation in paragraph (d)(2) of this provision. If the Offeror has responded "does" in the representation in paragraph (d)(2) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment--

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known);

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

(End of provision)

#### 52.204-26 COVERED TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (OCT 2020)

(a) Definitions. As used in this provision, "covered telecommunications equipment or services" and "reasonable inquiry" have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

##### Price and Past Performance (Best Value Tradeoff)

The Government will award on the basis of price unless the Contracting Officer is aware of past performance information related to the low price quote/offer which indicates that quote/offer may not represent best value. In that case, the Government reserves the right to consider the past performance of other quotes/offers, conduct a price, past performance tradeoff, and award to other than the lowest price quote/offer.

(b) *Options.* N/A

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. - (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Predecessor" means an entity that is replaced by a successor and includes any predecessors of the predecessor.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(a) Method of payment. (1) All payments by the Government under this contract shall be made by electronic funds transfer (EFT) except as provided in paragraph (a)(2) of this clause. As used in this clause, the term “EFT” refers to the funds transfer and may also include the payment information transfer.

(2) In the event the Government is unable to release one or more payments by EFT, the Contractor agrees to either--

(i) Accept payment by check or some other mutually agreeable method of payment; or

(ii) Request the Government to extend payment due dates until such time as the Government makes payment by EFT (but see paragraph (d) of this clause).

(b) Mandatory submission of Contractor's EFT information. (1) The Contractor is required to provide the Government with the information required to make payment by EFT (see paragraph (j) of this clause). The Contractor shall provide this information directly to the office designated in this contract to receive that information (hereafter: “designated office”) **by the date when the contractor submit first invoice, using EFT Form established by DFAS**. If not otherwise specified in this contract, the payment office is the designated office for receipt of the Contractor's EFT information. If more than one designated office is named for the contract, the Contractor shall provide a separate notice to each office. In the event that the EFT information changes, the Contractor shall be responsible for providing the updated information to the designated office(s).

(2) If the Contractor provides EFT information applicable to multiple contracts, the Contractor shall specifically state the applicability of this EFT information in terms acceptable to the designated office. However, EFT information supplied to a designated office shall be applicable only to contracts that identify that designated office as the office to receive EFT information for that contract.

(c) Mechanisms for EFT payment. The Government may make payment by EFT through either the Automated Clearing House (ACH) network, subject to the rules of the National Automated Clearing House Association, or the



Fedwire Transfer System. The rules governing Federal payments through the ACH are contained in 31 CFR part 210.

(d) Suspension of payment. (1) The Government is not required to make any payment under this contract until after receipt, by the designated office, of the correct EFT payment information from the Contractor. If such suspension would result in a late payment under the prompt payment terms of this contract, the Contractor's request for suspension shall extend the due date for payment by the number of days of the suspension.

(e) Liability for uncompleted or erroneous transfers. (1) If an uncompleted or erroneous transfer occurs because the Government used the Contractor's EFT information incorrectly, the Government remains responsible for--

- (i) Making a correct payment;
- (ii) Paying any prompt payment penalty due; and
- (iii) Recovering any erroneously directed funds.

(2) If an uncompleted or erroneous transfer occurs because the Contractor's EFT information was incorrect, or was revised within 30 days of Government release of the EFT payment transaction instruction to the Federal Reserve System, and--

- (i) If the funds are no longer under the control of the payment office, the Government is deemed to have made payment and the Contractor is responsible for recovery of any erroneously directed funds; or
- (ii) If the funds remain under the control of the payment office, the Government shall not make payment and the provisions of paragraph (d) shall apply.

(f) EFT and prompt payment. A payment shall be deemed to have been made in a timely manner in accordance with the prompt payment terms of this contract if, in the EFT payment transaction instruction released to the Federal Reserve System, the date specified for settlement of the payment is on or before the prompt payment due date, provided the specified payment date is a valid date under the rules of the Federal Reserve System.

(g) EFT and assignment of claims. If the Contractor assigns the proceeds of this contract as provided for in the assignment of claims terms of this contract, the Contractor shall require as a condition of any such assignment, that the assignee shall provide the EFT information required by paragraph (j) of this clause to the designated office, and shall be paid by EFT in accordance with the terms of this clause. In all respects, the requirements of this clause shall apply to the assignee as if it were the Contractor. EFT information that shows the ultimate recipient of the transfer to be other than the Contractor, in the absence of a proper assignment of claims acceptable to the Government, is incorrect EFT information within the meaning of paragraph (d) of this clause.

(h) Liability for change of EFT information by financial agent. The Government is not liable for errors resulting from changes to EFT information provided by the Contractor's financial agent.

(i) Payment information. The payment or disbursing office shall forward to the Contractor available payment information that is suitable for transmission as of the date of release of the EFT instruction to the Federal Reserve System. The Government may request the Contractor to designate a desired format and method(s) for delivery of payment information from a list of formats and methods the payment office is capable of executing. However, the

Government does not guarantee that any particular format or method of delivery is available at any particular payment office and retains the latitude to use the format and delivery method most convenient to the Government. If the Government makes payment by check in accordance with paragraph (a) of this clause, the Government shall mail the payment information to the remittance address in the contract.

(j) EFT information. The Contractor shall provide the following information to the designated office. The Contractor may supply this data for this or multiple contracts (see paragraph (b) of this clause). The Contractor shall designate a single financial agent per contract capable of receiving and processing the EFT information using the EFT methods described in paragraph (c) of this clause.

- (1) The contract number (or other procurement identification number).
- (2) The Contractor's name and remittance address, as stated in the contract(s).
- (3) The signature (manual or electronic, as appropriate), title, and telephone number of the Contractor official authorized to provide this information.
- (4) The name, address, and 9-digit Routing Transit Number of the Contractor's financial agent.
- (5) The Contractor's account number and the type of account (checking, saving, or lockbox).
- (6) If applicable, the Fedwire Transfer System telegraphic abbreviation of the Contractor's financial agent.
- (7) If applicable, the Contractor shall also provide the name, address, telegraphic abbreviation, and 9-digit Routing Transit Number of the correspondent financial institution receiving the wire transfer payment if the Contractor's financial agent is not directly on-line to the Fedwire Transfer System; and, therefore, not the receiver of the wire transfer payment.

- (2) Items included on the Commerce Control List set forth in Supplement No. 1 to part 774 of the Export Administration Regulations under subchapter C of chapter VII of title 15, Code of Federal Regulations, and controlled--
  - (i) Pursuant to multilateral regimes, including for reasons relating to national security, chemical and biological weapons proliferation, nuclear nonproliferation, or missile technology; or
  - (ii) For reasons relating to regional stability or surreptitious listening;
- (3) Specially designed and prepared nuclear equipment, parts and components, materials, software, and technology covered by part 810 of title 10, Code of Federal Regulations (relating to assistance to foreign atomic energy activities);
- (4) Nuclear facilities, equipment, and material covered by part 110 of title 10, Code of Federal Regulations (relating to export and import of nuclear equipment and material);
- (5) Select agents and toxins covered by part 331 of title 7, Code of Federal Regulations, part 121 of title 9 of such Code, or part 73 of title 42 of such Code; or
- (6) Emerging and foundational technologies controlled pursuant to section 1758 of the Export Control Reform Act of 2018 (50 U.S.C. 4817).

Substantial or essential component means any component necessary for the proper function or performance of a piece of equipment, system, or service.

(b) Prohibition. In accordance with section 1656 of the National Defense Authorization Act for Fiscal Year 2018 (Pub. L. 115-91), the contractor shall not provide to the Government any equipment, system, or service to carry out covered missions that uses covered defense telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system, unless the covered defense telecommunication equipment or services are covered by a waiver described in Defense Federal Acquisition Regulation Supplement 204.2104.

(c) Procedures. The Contractor shall review the list of excluded parties in the System for Award Management (SAM) at <https://www.sam.gov> for entities that are excluded when providing any equipment, system, or service, to carry out covered missions, that uses covered defense telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system, unless a waiver is granted.

(d) Reporting.

(1) In the event the Contractor identifies covered defense telecommunications equipment or services used as a substantial or essential component of any system, or as critical technology as part of any system, during contract performance, the Contractor shall report at <https://dibnet.dod.mil> the information in paragraph (d)(2) of this clause.

(a) Definitions. As used in this clause-

Automatic identification device means a device, such as a reader or interrogator, used to retrieve data encoded on machine-readable media.

Concatenated unique item identifier means--

(1) For items that are serialized within the enterprise identifier, the linking together of the unique identifier data elements in order of the issuing agency code, enterprise identifier, and unique serial number within the enterprise identifier; or

(2) For items that are serialized within the original part, lot, or batch number, the linking together of the unique identifier data elements in order of the issuing agency code; enterprise identifier; original part, lot, or batch number; and serial number within the original part, lot, or batch number.

Data Matrix means a two-dimensional matrix symbology, which is made up of square or, in some cases, round modules arranged within a perimeter finder pattern and uses the Error Checking and Correction 200 (ECC200) specification found within International Standards Organization (ISO)/International Electrotechnical Commission (IEC) 16022.

Data qualifier means a specified character (or string of characters) that immediately precedes a data field that defines the general category or intended use of the data that follows.

DoD recognized unique identification equivalent means a unique identification method that is in commercial use and has been recognized by DoD. All DoD recognized unique identification equivalents are listed at <https://www.acq.osd.mil/asda/dpc/ce/ds/unique-id.html>.

DoD item unique identification means a system of marking items delivered to DoD with unique item identifiers that have machine-readable data elements to distinguish an item from all other like and unlike items. For items that are serialized within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier and a unique serial number. For items that are serialized within the part, lot, or batch number within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Enterprise means the entity (e.g., a manufacturer or vendor) responsible for assigning unique item identifiers to items.

Enterprise identifier means a code that is uniquely assigned to an enterprise by an issuing agency.

Government's unit acquisition cost means--

(1) For fixed-price type line, subline, or exhibit line items, the unit price identified in the contract at the time of delivery;

(2) For cost-type or undefinitized line, subline, or exhibit line items, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery; and

(3) For items produced under a time-and-materials contract, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery.

Issuing agency means an organization responsible for assigning a globally unique identifier to an enterprise, as indicated in the Register of Issuing Agency Codes for ISO/IEC 15459, located at [http://www.aimglobal.org/?Reg\\_Authority15459](http://www.aimglobal.org/?Reg_Authority15459).

Issuing agency code means a code that designates the registration (or controlling) authority for the enterprise identifier.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

Parent item means the item assembly, intermediate component, or subassembly that has an embedded item with a unique item identifier or DoD recognized unique identification equivalent.

Serial number within the enterprise identifier means a combination of numbers, letters, or symbols assigned by the enterprise to an item that provides for the differentiation of that item from any other like and unlike item and is never used again within the enterprise.

Serial number within the part, lot, or batch number means a combination of numbers or letters assigned by the enterprise to an item that provides for the differentiation of that item from any other like item within a part, lot, or batch number assignment.

Serialization within the enterprise identifier means each item produced is assigned a serial number that is unique among all the tangible items produced by the enterprise and is never used again. The enterprise is responsible for ensuring unique serialization within the enterprise identifier.

Serialization within the part, lot, or batch number means each item of a particular part, lot, or batch number is assigned a unique serial number within that part, lot, or batch number assignment. The enterprise is responsible for ensuring unique serialization within the part, lot, or batch number within the enterprise identifier.

Type designation means a combination of letters and numerals assigned by the Government to a major end item, assembly or subassembly, as appropriate, to provide a convenient means of differentiating between items having the same basic name and to indicate modifications and changes thereto.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

Unique item identifier type means a designator to indicate which method of uniquely identifying a part has been used. The current list of accepted unique item identifier types is maintained at <https://www.acq.osd.mil/asda/dpc/ce/ds/unique-id.html>.

(b) The Contractor shall deliver all items under a contract line, subline, or exhibit line item.

(c) Unique item identifier. (1) The Contractor shall provide a unique item identifier for the following:

(i) Delivered items for which the Government's unit acquisition cost is \$5,000 or more, except for the following line items:

(2) The unique item identifier assignment and its component data element combination shall not be duplicated on any other item marked or registered in the DoD Item Unique Identification Registry by the contractor.

(3) The unique item identifier component data elements shall be marked on an item using two dimensional data matrix symbology that complies with ISO/IEC International Standard 16022, Information technology--International symbology specification--Data matrix; ECC200 data matrix specification.

(4) Data syntax and semantics of unique item identifiers. The Contractor shall ensure that--
